### How to tackle the situation

American Academy of Ophthalmology has issued guidelines to start back the practice and surgeries. The most important thing there is to follow the precautionary measures so that the virus can be contained and there is no spread of the virus particles [1,2].

### Main points to remember

- Limit the patient visits, allow patients only with prior appointment and who requires urgent medical attention, ask experienced optometrist or junior ophthalmologist to handle the call for appointments to assess the emergence for patient appointments

- Face masks should be made compulsory for every staffs and patients, keep extra masks available in the reception desks so that if anyone comes without masks you can provide them one
- Hand sanitizers with more than 60% of ethyl alcohol should be placed in different places inside the hospital/clinics
- Put instruction posters about wearing masks, hand sanitizing and physical distancing where it is clearly visible to patients and staffs
- Instruct physical distancing of 1.5 meter between every person inside your hospital if possible, put individual chairs only, removes multiple sitting benches
- Patients who come to an appointment should be asked prior to entering the waiting room about fever and respiratory illness and whether they or a family member have had contact with another person with confirmed COVID-19 in the past 2 to 14 days. If they answer yes to either question, they should be sent home and told to speak to their family doctor about testing
- All devices and desks which comes contact with the patients should be sanitized regularly
- Keep an isolation room separately, use it only for patients with red eyes or conjunctivitis, as it has been seen that conjunctivitis is associated with COVID-19.
