



Orthopads CZ are Mass Working in Contradiction to Principles Logics and Implanting Processing Laws?

Annotation: In each OECD countries, there are parallelly risky working many industrial extremal dangerous Branches. There must be very carefully, and safety linked processing operation of very dangerous production and industrially supplied all Client services – in produce the electric Energy in nuclear power stations, in produce of computers, in produce Weapons, Cosmic Rackets, Mining, Chemistry, etc.

For example, we are knowing 100 years duration history with massive growing production of passenger cars and trucks, there must be realised so as complementary road safety intensive traffic on international highways. Also, there parallelly similar managed all production and safety usage of large transport aircrafts and the continuous complementary safety Quantum and Qualities of management for continuous international airport network. It means including the performance and IT support of certificated repair all clever technical services for example by Mass frequent usage Boeing 707 aircraft – in parallelly usage in many States OECD. There must be all ways perfect testing, so as of mental, physical and level knowledges and skills of pilot crews with a guarantee of minimizing next air traffic catastrophes, etc. We used for it many types of computerised Technical Simulators with IT dynamical support for decision making on Pilot Trenagers, with modelling probablistic more stressing situation for education pilot staff, etc.

In comparison with dangerous Mass orthopadic processing by Health care, we have many logical and methodic reserves in guarantee perfect levels for safety and legal creating individual Clinic Plans for Patients and informal Sources for actual managing perfect legal realisation of similar orthopadic standard Mass surgeries by Approval processing Patterns from Clinic Testing Medical Devices - implants.

I would to show some repeated Mass fatal medical mistakes in implanting standard Total hip arthroplasty in Orthopady CZ. What is Legal or Illegal implanting Medical processing in Orthopady CZ and what there are differences in legal evaluation medical implanting processing in Orthopady OECD? My orthopedist misfolded the shape in the proximal part of the femoral bone cavity because he did not respect the radiologically documented preoperative dysplastic deformation of my right femoral bone neck. When attempting to manually thrust the stem component into the femoral axis, the spike of the metal shaft broke through a false hole in the wrongly shaped hole - at a tragic angle of 13.68 degrees when the tolerance is defined by Producer +/- 1 degree! Orthopedics CZ had to come to their fault at the latest during the functional biomechanical test of the complete assembly of the TEP hip set into the patient's body, but such a basic technical functional knowledge and skills of orthopedics CZ often does not. So as my Radiologist CZ realised the first Postoperative RTG image to late – till 3. Days after tragic Polytrauma on Surgeon Hall “Fausse route Stem”, but Radiolog didn't respect the legal duties to analyse the position of the spike metallic stem on coordinates Xi, Yi, Zi on the orthopadic screen in the functional Depth of the Femoral cavity - and by standard comparison with Firm installing radiologic Masks in the same scaling - or by usage double parallel 2 perfect situated RTG postoperational images - with a rotation of RTG Emitter all ways about angle 90 Grads round the Femoral bone. The Czech Orthopads and Radiologs CZ don't respecting the Product invoid, product assembling rules for set THA – Bicontact S, nocemented, from the Firm B. Braun Germany, they have got false Certificated as Users this Orthopadic implants, when such understanding is fully stupid contrary principles Biomechanics, Geometry 3 D, legal processing by implanting to Directe 93/42/EEC Medical Devices. All changed medical fatal illegal mistakes are constant evaluated as LEGE ARTIS CZ – by the false Court Medical

Messages of the Knowing Medical Institutes CZ, by the Criminal Police CZ, by Justice CZ – Contrary Civic Constitutional Human Rights CZ.

All types of dangerous Industries are always used the systematic parallelly Testing in Technical and Client evaluation progressive legal requirements for perfect long usage Medical Devices. We could define acceptable legal views and individual planning and realisation conditions - by systematic usage respects to implanting Laws, with usage random Samples by continual testing Qualities. Bbut we are just ignoring Tests of yearly Produce Health care in Orthopadic Clinics OECD with systematic statistic multilateral comparison Effects among similar Orthopadic Clinics, namely in similar important Clusters _of Orthopadic Patients with similar Diagnoses, with similar Treatments, with similar usage Medical implants, with similar IT support, with similar usage Medical Radiology...with probable similar repeated fatal medical mistakes in interpretation RTG images in context to Geometry 3 D, with similar frequent repeated medical mistakes in false functionality of impalnts contrary rules of Biomechanics, in systematic controlling duties to respect preliminary individual Health status of Patients in Clinic Plans, including problems with Osteoporoses, with mistakes by ignoring individual preliminary Health Status by individual dysplastic declination of Patient bones, etc.

The Comparison the Types_of fatal systematic mistakes in Orthopady CZ with daily risks in prevency mistakes by dangerous elementary Chemical processing

If you worked in a laboratory as a qualified Chemist, you should be deeply respected and accountable for adhering to precise official archiving Firm guidelines for the realization of documented sample todays chemical processing. Already as each Beginner in the first student year of the Czech Technical University Prague – Chemical Faculty, you would know that if, - for example, maybe in the 7th partial step activity, you have to pour slowly the XXX fluid into the mixed resulting finished fluid "XYY" as a perfect solution, Because if you do this with a mistakes in identity fluids, bad sequential realisation or by false technolgc processing Physical conditions - or if you do not do it in right planning time – 8 Minutes after technologic planned pause with defined mixed structure and by continual working Temperature in limits 67 till 83 Gradus of Celsium - it will be eventually suddenly exploding!!! – unnecessarily risks, probable tragic for your own private eyesight, and still be threatened by the lives of another your 4 colleagues – in the same laboratory working as other Technicians – when there are working in the same

laboratory parallelly and each on their own individual tasks. On this simple explanation, it is easy to manifest what is the „right word processing in laboratory chemical procedures with your own responsibility, what is the binding in fixed sequences of partial operations with defined technical conditions, instruments measurement. You need inputing raw certificated attested materials and there are clear – what you need as standard equipment in your laboratory workplace. There are need to have which gauges and defined containers, Approval technologic individual Plan for each your partial sequential activities in defined individual whole coherent working task, there are usual defined Air Conditions with a perfect laboratory ventilation, you should have working firm lab uniform and specific gloves, specific glases -, private personal safety set – you should take specific regulated gas burners, in the room must be used lifting and acustic signalisation for well-defined Dangerous Situations – and there are perfect controlled who may be present at your workplace, we should know - how will be monitoring of your important actions - it will be done, for example, by systematic Video-recording with Signalisation legal duties to immediately realised measurement for important partial finished phases and partial results. - according to archiving the binding Input technological documents and so as Outputs archiving working documents, who is your assignor. On leading responsibility the Head for whole daily working Laboratory in Protocoling date „XX.XX.XXXX“ and who is preliminary controlled your own initial Certified Professional Qualification and practical skills for your defined workplace with Health and Safety education – always it must to be authorized to realise planning process with exwaitng the perfect standard acceptable results – so as including checked by random Samplings in the Independent Outcome Control of the Department Laboratory „LLL“ - Whether the Result of Your Work Is Compliant with the Initial Entry in All Parameters by the controlling List, Keeping the correct cleanness and density of the output semi-finished product - according to all legal requirements Laws, according to valid industry by Branched standards and according to the set of regulations specified for your specific workplace in the Identity NNN by employer company FIRM „AAA“, including instructions on which crates and what security measures you’re the List results - for example, the amount of output fluid and re-manipulation all waste materials. passed on to the intermediate storage for finished Semi-products, with clear protocolled identification, who was the processor, who was responsible for the continual controller system, who was responsible as a ware housekeeper, who was the manager of today's shift in the laboratory, who began worked out the Planning Task Schedule laboratories for today's work shift???, Who controlled the legal Start your processing with fulfilling all legal summary Inputs

--+ Technician and Informal legal conditions for your Beginning work, etc. All working activities in all dangerous Industries are realised in logical and very narrow defined multilateral limits for legal workflow! In Orthopaedic processing CZ the safety and legal conditions with minimize Patient risks, it is in Orthopady CZ a false Reclam Slogan CZ only.

The Orthopads CZ are smiling after „Unhappy of Patients L, when by case a false illegal dysfunctional placement the Orthopaedic implants in Patient body...there are actual mortal risks for Orthopaedic Patient CZ only – no risks and responsibility for Physicians, because all organisational, technical, timing, medical processing with many changed fatal illegal medical mistakes...there are classified always in Czech Republic as “A Patient Unhappy in medical working medical staff only in Limits Lege Artis CZ always, without Doubts”.

My Orthopad MUDr. František Vurm, began implanting on Clinic Orthopaedic Hall in date November 13, 2007 – blendy and intuitive illegal ways - without mandatory individual Clinic Plan for Legal, Safety and Functional placement set “Total Hip Arthroplasty, non-cemented” in my body, despite there are explicit defined as illegal: by the Directive 93/42/EEC Medical Devices, despite there are so as illegal - contrary principles usage dangerous products – Orthopaedic implants with „CE_marking“ contrary mandatory preventy risks by usage Approval set THA on common Mark t EU: For The Type Non cemented Bi contact S, from the firm B. Braun Germany – contrary firm Product invoid, contrary Certification of all Orthopad Users by elementary explanation implanting processing by the Firm B. Braun Education Lectures for right and safety usage firm installing and measurement instruments – including usage Radiologic Firm Masks for sagittal and radial controlling Placement by individual Clinic Plans and so as by individual post operational RTG images - in the same scaling with perfect detection all critical dysfunctional biomechanical and geometric false Positions, namely for the Spice of the metallic Stem. There are defined a tolerancy of coaxialities between th Stem and the femoral bone, Angle +/- 1 Gradus, but Orthopads CZ including Medical Knowing Institutes CZ and Criminal Police CZ accepting as work realised „Lege artis CZ“ the differences 10x out of the field Angle Tolerance 13,68 Gradus. and „Post operational Patient Fall“ it is no Chance to stop illegal substitutes „Trueth“ and „False“ kin evaluation legal Results in a like hood medical „Ad hoc“ biomechanical Hypothseses CZ. The Forensic Doctors realised false Court Testimonies and They ignored my casual inforced full Plegia Nervus Ischidici in right underknie, my often repeated dangerous falls by skeletal dysbalance, destruction all musculature in right Underknie, inforced Leukemia B-CLL after many inforced radiologic RTG paging with extremal strong ionisation radiation. Yes, just I am needless dying!

Implanting THA O.K. – it was false declared since November 13, 2007 in the operational Protocol on Surgeon Hall by Orthopad MUDr. F. Vurm - so as in resulting The Judgement in my Regional Court Prague CZ No 36 C 181/2009. UNBELIEVED!

I have got fatal needless illegal Orthopaedic heavy injuring and with the continual growing next complicated multilateral Health diseases after “FAUSSE ROUTE STEM”. I am just casual needless preliminary dying Patient CZ!

Such my inforced judicial Civic Execution was realised in a Complot of my medical Culprits Orthopads CZ and with Medical Forensic Experts CZ of the Knowing Medical Institute CZ - namely from the famous Participant – The Central Army Hospital Prague CZ, it was wisdom realised by written by the Court Medical Message No. 36 C 181/2009-123 since March 27, 2012 as a informal Input to false argumented resulting finished Judgement.

The Criminal Police CZ so as the Ombudsman CZ, so as the Constitutional Court CZ refused all criminal and judicial controls - a like hood renewing the Court trial as a Penalty Criminal Court with my validated Criminal evidences only since first Inputs judicial documents from date November 2009 on the Regional Court Prague No. 36 C 181/2009.

All my Court Participants as false Guarants on the justified. The Judgement No. 36 C 181/2009-221 since September 24, 2012 - there are just exwaiting my Death with their common light smiling, because I am just illegal dying - despite as a qualificated State investigator in field occupational mortalities.

padic Health care - there are namely Notices out of today's legal Fashioned Czech Republic as a Member of EU - despite with constant ignoring international implanting Laws EU/CZ in safety legal Health care CZ by orthopaedic human implanting, with parallelly ignoring official formal guarantee of the private Constitutional Civic Human Rights CZ on the justified validated Court trials CZ only: for all Citizens CZ, with the verified judicial validated Criminal Arguments of each respectable Plaintiff CZ - so as by Biomechanics, Radiology 3 D, Geometry 3 D, with continual systematic controlling all activities implanting activities, exactly by the Laws EU/CZ - step by steps all Legal and Illegal medical processing activities in standard Health care - The Classic Total Hip Arthroplasty - similar as we could repeated again arguments as in Approval Pattern, namely from finished Clinic Tests defined Medical Devices - so as we could realise legal and Safety in hospital Orthopaedy Clinics network CZ, EU, OECD in similar Clusters Orthopaedic Patients.

Remember me, as a needless dying Scientist by my intensive scientific experiment to cancel for ever - all repeated logical illegal informal disproportion and growing entropy in interfaces in communication Channels - between Technics and Medicine in Orthopaedic workflow with Approval Medical Devices in OECD.

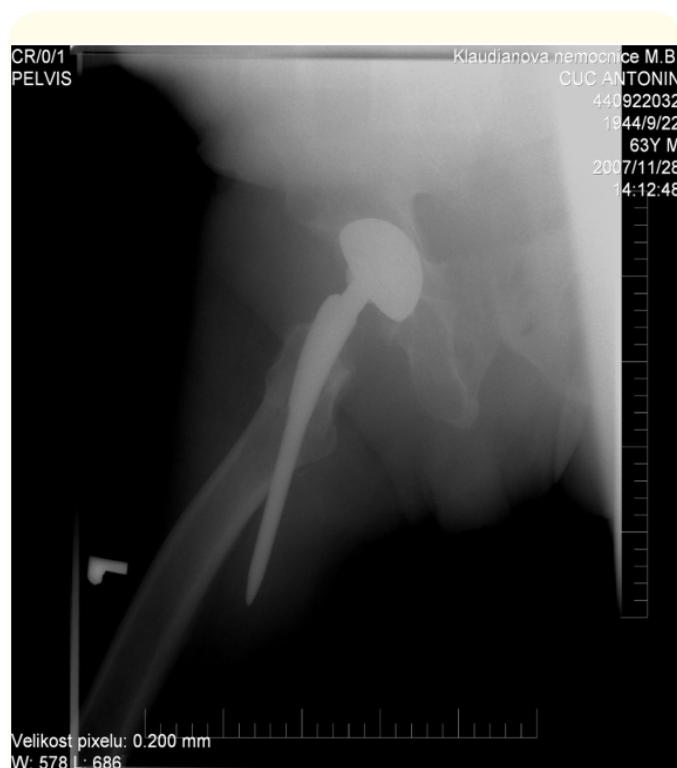

The Diagnose "Fausse Route Stem" since Orthopaedic Surgeon from date November 13, 2007 on the Regional Hospital Mladá Boleslav CZ, the reopartion THA was realised till after 17 days, when the Orthopaedist MUDr. František Vurm didn't realised mandatory individual Clinic Plan, he ignored preliminary dysplastic placement the femoral neck on my right femoral bone, which was defined in Patient Health Radiologic documentation before Orthopaedic surgery. The Orthopaed MUDr. F. Vurm began working illegal - blendy and intuitive ways, without Clinic Plan, he realised false hole in the proximal femoral cavity without adequated controlling internal Form, By hitting the Stem, the trajectory of the Spike of Metallic Stem was false - out of coaxiality the Stem and femoral Axe in angle 13,68 Gradus, while time there are defined for right assembling the tolerance +/- 10 Gradus by the Producer of set THA - Bicontact S, noncemented, from firm B. Braun Germany in nominal Dimense Stem 13 mm in Type "N". The prime Radiologist realised to late the first post operational RTG image sof implantation - but the Radiologist interpreted the RTG Image since date November 16. 2007 illegal - by the intuitive observing only, hen there are explicit duties to respekt the firm Invoid, Firm Installing and Measurement set for implantation, firm defined mechanical accuracy to assmebling the biomechanical functional Product, Its's impossible, when the Orthopads, Radfiologist, forensic Doctors didn't respecting Criminal Tracing in Criminal Anthropology, in interpretation RTG images by principles Geometry 3 D, by guarance the biomechanics functionality all.

Orthopaedic implants in Patient Body by Directive 93/42/EEC Medical Devices and by Certificated International Lectures for all Users by firm B. Braun Germany - Aesculap. The resulting medical Hypotheses of Court Medical Message No 36 C 181/2009-123 since date March 27, 2012 firm the Central Army Hospital Pargue CZ "the implanting processing was realised in controlling limits LEGE ARTIS CZ and the Polytrauma "Fausse route stem" was realised till as "a Patient Post operational Happend Fall" - it is criminal nonsense for ever and a horrible Betrayal the multilateral World Science.

The Judgement No 36 C 18991/2009-221 since September 24, 2012 it was derived from the False Court Medical Message with repeating againfalse results „Unhappy of the Patient by post operational Fall by perfect working Medical staff in the hospitál Mladá Boleslav CZ in date November 13, 2007". None my preliminary Criminal evidences about TRUETH were accepting by Participants of the Regional Court Trial CZ - No 36 C 181/2009 so as by Court dealing in Competency Judge - JUDr. Vojtěch Cepl, despite it _is

contrary Constitutional processing rules CZ and contrary my Constitutional Civic Human Rights to participate on justified validated Court Trials CZ only with respecting a Plaintiff to place Criminal evidences to judicial dealing. I have no judicial justified support from the Justice CZ, nor from the Czech Ombudsman, nor from the Constitutional Court CZ, nor from the Criminal Police CZ. It seems to be wisdom my public Execution as a Scientist CZ and an Expert in Cybernetics and in field Health and Safety Medical Devices EU/CZ, just I am needless heavy crippled and needless casual preliminary dying Orthopaedic Patient CZ [1-3].
