Contrary to these, some animal owners wish and practice and tries to implement unethical and completely against the welfare of animals. They are self-centered, immoral, and unable to lead themselves on the right track who consider themselves as a boss and want to accomplish everything they want on their animals. These people tend to even mislead veterinarians to respond only to their will. These misleaders want to get rid of their animals whenever they want that they have to do. They are not open to take ideas from others.

Through the practices of intensification of farms, modernization of human life, advancing research and technology, factory-farming and so on, human beings brought persistent problems to veterinarians and the welfare of animals. To mention some of these: Confinement of animals in small areas in barn, pen and the like which can't allow them even to turn and let down, densely stocking animals where they can develop abnormal behaviors of fighting each other and other complications like respiratory diseases and communication of these diseases amongst easily, genetic engineering, crossing, cloning, stem cell technologies and the like which widely and deeply complicated the health and well being of animals and expose the animals to life challenges for existence and also put their unreserved hands in human welfare are some among the top priorities. These are all originated from the human mind and their effect bounce to humans particularly veterinarians.

There may be no one to deny that all these attempts of human have impacted his life positively by providing quantity and quality animal products and by-products let him have a sustainable life. But the then unpredicted or undermined negative impacts put human life and welfare of animals under challenges that now out bulge and enforce human beings to seek urgent solutions.

#### **Companion animal welfare**

As the name indicates these are animals kept to accompany humans in their life. Look! the idea is wrong from its very beginning. Companionship in its very nature is mutual, entered passively by a drive of common interest of all parties in an association. This is not the case in human-companion animal companionship which is entered based on the sole interest of humans. This tends to give human full right on the manipulation of the companionship. This case may be aggravated by the weak thought of the human owner. At one time the owner may let his companion animal exercise extraordinary life more than a value he gives for other human beings by the weak personal value he gives for others. At another time he wants to throw them out the same animal he gave extraordinary virtue as if those animals are a 'use and through' material forgetting them a sentient thing. Again what is surprising is that those class of human beings who put themselves as animal advocates tend to keep silent, revealing their failure to say the rights right and wrongs wrong.

Pet owners and other companion animal owners sometimes develop an interest to keep some breed of animals which are maybe results of gene modification. As these animals become aged or encounter health complications usually deformities, these owners refrain from helping these animals and don't want to stand by their side. Their selfish and unpredictability is then pushed to veterinarians challenge, a case which continuously put veterinarians in an ethical dilemma in decision making.

#### The case in Ethiopia

As I have indicated earlier in the text, the veterinary profession has given lesser attention in the country mostly originated from the lesser value given to health and above this to the welfare of animals. In a country where more valued human beings do not get due attention, how could one get moral to talk about animal

Entangled in it there is also an inclination toward using companion animals as an indicator of 'civilization'. Without any rational reason some citizens possess companion animals investing huge money without knowing how to handle these animals. These companion animals particularly pets are suspected to be the primary sources of different potential exotic and zoonotic diseases recently becoming a problem to the nation and animals nationwide [1-11].

#### **Conclusion and Recommendations**

Animal welfare is a global issue and almost complex to the present thought and mindset of the world society. It may easily be twisted to its wrong dimension. Unless some corrective measures will be taken, animal welfare issues may escape out of its real track and may follow some wrong unreversed line.

Here are some of my recommendations as a remedy solution for the future:

- Reform and better mindset among animal advocates should be sought to put animal welfare issue on its right track.
- Animal welfare, right and ethics should properly be defined avoiding exaggeration to lay a foundation for the next generation which can put them out of the dilemma.
- World society should be thought not to keep companion animals without convincing reasons and quit the companionship again without any convincing reasons.
- All relevant legislation should be designed and be internationally harmonized to protect the well being of animals and the integrity of humans.
